Terms of Service

The signatory agrees that the organization stated on this form in the section labelled "Name of Organization" (henceforth to be referred to as "The Organization") is to participate in Pennzoil 10 Minute Oil Change Centre's Community Partnership Program. The Signatory agrees that any money that is donated from Pennzoil 10 Minute Oil Change Centre to The Organization will be used solely for operational costs and to carry out the purpose of The Organization as stated in this form in the section labelled "Summary of Organizational Purpose". If it is discovered that the donations received through the Community Partnership Program are being used for any other purpose other than what is permitted by Pennzoil 10 Minute Oil Change Centre, the signatory will be required to return all donations received from Pennzoil 10 Minute Oil Change Centre.

Pennzoil 10 Minute Oil Change Centre reserves the right to modify the Terms of Service of the Community Partnership Program at any time with notice to you. The notice will be provided to you within a timeframe of the date of the change that Pennzoil 10 Minute Oil Change Centre deems reasonable. Pennzoil 10 Minute Oil Change Centre also reserves the right to terminate the inclusion of The Organization in the Community Partnership Program at any time given that a 15 day notice has been provided.

The Organization has the right to terminate its involvement in the Community Partnership Program at any time considering a notice of at least 30 days has been given. If The Organization is unable to participate in the Community Partnership Program for any reason, Pennzoil 10 Minute Oil Change is to be notified immediately of the cancelation and purpose. This includes, but is not limited to, instances such as bankruptcy, closure of the organization/program, expiration of the program, and revoked business license.
